# Aircraft Maintenance Engineering Course (A.M.E.)

Presently the aviation industry is one of the fast growing industries, in our country with the Indian Government's open sky policy, many private players are entering this field, creating huge employment opportunities. Playing a stellar role in this sector are Aircraft Maintenance Engineers, who ensure that the aircraft is in immaculate condition before take-off. An Aircraft Maintenance Engineer (AME) is basically a person licensed to ensure that the aircraft is airworthy and in accordance with the National and International Aviation standards.

In short, Aircraft Maintenance Engineer is the sole person responsible for the maintenance and overhaul of aircraft. Only Aircraft Maintenance Engineer can certify that the aircraft is fit for flying.

Approval has been granted by the Director General of Civil Aviation, Govt of India to our institutes for conducting Aircraft Maintenance Engineering course in accordance with the Civil Aviation Requirements Section 2-Airworthiness, Series-E, Part-I & Part-VIII. These Civil Aviation Requirements are issued in accordance with Rule 61 and Rule 133B of the Aircraft Rules 1937 derived from the Aircraft Act 1934 (XXII to 1934) passed by Parliament. Under the Aircraft Rules, Director General of Civil Aviation (DGCA) is the regulatory body to deal with all matters pertaining to Civil Aviation in the country.

# Fee Structure & Mode of Payment

## **Rules About Fees**

- The student should submit the prescribed application from duly filled in along with the institution fees.
- Once a candidate is admitted to the Institute, the fee is neither refundable nor it can be transferred to any other account. All reasons shown for refund or transfer will be turned down.
- Caution money is however refundable at the end of the completion of course. Damages of any sort is liable to be deducted from the caution money.
- Registration & Examination Fee of D.G.C.A. will be charged extra in addition to the Institutions Fee. However, this kind of fees will be nominal as per rules of D.G.C.A.
- The student may be asked to produce the receipts of the fees paid by them, as and when required. Hence he/she must preserve the receipts with him/her.

# Library Facility

An enriched library is an essential requisite of an Engineering or Technical Institution. The library is a mirror of the current advancement occurring in the sphere of Technology & Engineering. We also provide Audio/Video facilities for better understanding of the subjects to impart knowledge to the students. The Institutes have libraries which have vast accumulation of authenticated books in multiple copies on various branches of Engineering & Technology.

## **Rules & Regulations**

- 1. The membership of the library is open to all the students of the institute who have paid their library fees.
- 2. A student desirous of borrowing books from the library must have an identity card issued by the Institute.
- 3. Only one book is issued at a time to a student.
- 4. Reference book will not be issued to any student.
- 5. No book can be issued twice a month to a student.
- 6. There is provision for study of the reference book in the library itself.
- 7. The Mutual transfer of the issued books are not allowed among the borrowers.
- 8. The books will be issued to the students only during the allotted time and date.
- 9. The students will be solely responsible for any damage or loss of the book caused by him or her and he/she may be asked to replace it.
- 10. A student can retain a book for 7 days only with him/her.
- 11. A fine of Rs. 25/- per day will be charged for retaining the book more than the specified period.

## Procedure For Admission To AME Course

Application for admission to the AME course should be made on the prescribed form, attached with the prospectus. Application Forms duly filled in capital letters should be sent along with the Registration fee Candidate seeking admission to the AME course should submit the application form along with .

- 1 Medical Form duly filled & Signed by a Registered Medical Practitioner.
- 2 Three Attested Copies of the Mark-Sheet of Qualifying Examination.
- 3 Character Certificate.
- 4 Admission Fee & Registration Fee.
- 5 Five Passport Size Photographs.
- 6 Four self addressed envelopes of size 9"x4" affixed with the postal stamps worth Rs. 40/- each.
- 7 Affidavit as enclosed (refer page 11& 12).
- 8 Duly signed copy of the fee structure sheet by the parent / student.
- 9 Once a category of AME course is opted, he or she can't shift to any other category of AME course.
- 10 A Demand Draft of the prescribed Fees at the time of admission should be submitted in favour of the respective institutions where the candidate prefers to take admission. In this regard, please take note of the following.

The Admission Fee is to be sent in the manner prescribed in the Fee structure. "FIRST COME FIRST SERVE" basis is adopted by the authority of the Institute while providing admission to the selected candidates. In case, a deserving candidate is not admitted due to the non availability of seats, such a student can reserve his/her seat for the next session by depositing the prescribed fees in advance to secure his seat.

In case a student does not receive any information regarding his or her admission within 20 days after the submission of completed application form, he or she should immediately get in touch with the Institute authority either personally or through correspondence. The candidate having outstanding gualification will always be preferred for admission.

Students appearing for the qualifying examination (10+2 with PCM) can also reserve their seats by taking provisional admission. In case after taking provisional admission, a candidate fails to score the required percentage of marks in the qualifying examination on the basis of which provisional admission was allotted, his or her fees will be refunded after deducting 30% of the admission fees.







# General Rules & Regulations

## **ADMISSION OF FOREIGN STUDENTS**

Admission for foreigners are dealt with under the rules framed by the Govt. of India, State Govt. & DGCA from time to time. Foreign student can obtain Prospects & Application Form on payment of US\$ 15. NRI Sponsored candidate seeking admission should submit sponsorship certificate, if required, along with the application form as per the Govt./DGCA rules.

## ATTENDANCE REQUIREMENT

To be eligible for appearing in any Examination a Student / Trainee should have at least 80% of attendance in the class

## CONDUCT OF STUDENTS

The following Rules & Regulations of the Institute shall be observed strictly.

- Every student should strictly adhere to the rules & regulations of the Institute.
- The student should be dressed neatly.
- Students should maintain the Tuition Notes & Records of Practical Work up-to-date. Tuition Notes & Practical Records will be checked by the Instructor every month. He/She should have a set of his or her own A.M.E. text books related to the subject and also tool kits.
- When syllabus is completed as per the lesson plan, the student's Tuition Notes & Workshop Records should be deposited with Chief Instructor (C.I.) for its scrutiny.
- Late comers should report to the C.I. before entering classes. In the absence of C.I., Dy. C.I. will deal with such cases. No student is allowed to leave class/workshop without prior permission of the Instructor incharge of the class/workshop Superintendent.
- All leave Applications will be addressed to the C.I. who is the sanctioning authority. Students who remain absent without prior leave application for more than a week should obtain the permission of the C.I before attending the next class. Minimum of 80% attendance is compulsory for every student to qualify for appearing in the semester exam, or else he/she shall be debarred from the Exam.
- In addition to our practical facilities, students should bear the expenditure for the additional cost (which will be nominal) for the practical if any arranged by the institute.

## **RAGGING**

Ragging among Junior & Senior Students is strictly prohibited with in & out of the premises of the Institute. A cordial relationship among the students is desirable & any violation of the disciplinary rules may invite stern action from the authorities.

## **BRIDGE CLASSES**

The aim of the Institute is to bring student's knowledge to the required standard of A.M.E. License Examination conducted by the D.G.C.A. Special classes will be arranged by the Institute for the benefit of the weak students if required.

## **Rules of Semester Pattern**

The syllabus will be followed as per the training manual of the institute approved by DGCA, Govt. of India. The course will be conducted in semester pattern, the semester examinations & promotions to higher semester will be strictly followed as per the DGCA norms. On job training will be provided as per the DGCA norms

## Refund of Fee

The Admission Fee & other fee paid by the student is spent by the Institute for providing better facilities to the student & also to meet the huge expenses incured, related to maintenance & other activities in order to provide quality Education. Hence no refund of fee is permissible once a candidate has been admitted to the Institute. The fee & the other charges once paid will under no circumstances be refundable, transferable or can be adjusted even if a student does not attend a single class. Students discontinuing in the middle of the course will forfeit the fee, other charge & security deposit.

## **Cancellation of Admission**

#### **GROUND EXAMINATION**

During the course, students will have to successfully clear the following examinations conducted by the DGCA, Ministry of Civil Aviation and WPC, Ministry of Communication for obtaining the following licences.

- ◆ Students' Pilot Licence (SPL).
- ◆ Endorsement on SPL for Cessna-152, 172 and Thorp T211.
- ◆ Flight Radio Telephony Operators licence (FRTOL).
- Private Pilot Licence (PPL).
- ◆ Commercial Pilot Licence (CPL).
- Radio Telephony- Restricted (RTR 'A')

Students are required to take written examinations stipulated by the DGCA at Bhopal or at any approved centers (Delhi, Chennai, Mumbai, Kolkatta etc.) to qualify for their licence. The DGCA Exam schedule can be obtained from the operation Office at Guna. The Radio Telephony exam conducted once in every two months at the various cities mentioned above.

#### **MEDIUM OF INSTRUCTION**

As per ICAO (International Civil Aviation Organization) standards, medium of instruction shall be in English. This language is used for all purposes of communication, lectures or for ATC communication. For students who do not have required proficiency in English and for those who do not have competancy in the language (less than 60% in their 12th standard), additional language classes are provided at extra cost.

#### **ADMISSION ESSENTIALS**

#### MEDICAL REQUIREMENT

Candidates are required to meet the medical standard as per the norms laid down by Director General of Civil Aviation (DGCA), New Delhi. At the time of admission, Student will have to undergo Class II Medical with the DGCA approved medical examiners. However, the candidates have to undergo a comprehensive Class-I Medical Examination at different DGCA approved centres before the issuance of the Commercial Pilot licence (CPL).

#### **SELECTION PROCESS**

A comprehensive selection procedure is followed for admission to ensure that only those who have the aptitude and the ability are admitted to the Academy. In case we find a candidate unfit for a particular course we monitor his caliber and aptitude so that he does not spend money and time on a course which may not be suitable for him.

#### WRITTEN TEST ·

This test forms an integral part of the selection procedure. There are certain mandatory test parameters like basic Maths, Physics, English and a paper consisting of 100 questions. The duration of the test is 90 mins. Successful applicants of the written composite paper are invited for the pilot aptitude test and Interview.

#### **BOARD OF INTERVIEW:**

A final round of Interview is conducted for successful candidates. Interviewers will also consist of Chief Ground Instructor & Chief Flying Instructor who are from the field of aviation.

#### **FINAL SELECTION:**

The final selection will be done on the basis of marks scored in the selection process.

#### **ADMISSION PROCEDURE**

Admissions for various courses take place in four quarters of the year depending on the availability of seats.

#### **APPLICATION FORM:**

The application form can be downloaded from the website or can be procured from Bhopal Head Office or from our other centres. The availability of the seats are also highlighted on the website: www.shashibgroup.org.

- Applications are only accepted on the prescribed format which can be downloaded from www.shashibgroup.org link to form.
- Application form duly filled in has to reach on or before the stipulated last date along with the
  respective fees in the form of a Demand Draft in favour of Sha- Shib Flying Academy,
  payable at Bhopal.
- Application is to be accompanied with attested copies (by Gazetted Officer) of all the certificates as mentioned in the admission form.
- Sha- Shib Flying Academy (A unit of Institute of Management & Technologies) has the right to reject or accept any application without giving any reason, thereof.
- Admission notices will be sent to the selected candidates intimating the dates on which they should report at the admission centre with the original certificates such as:
- Marksheet of the qualifying examination & pass certificate
- 12 Passport size colour photographs with name of the candidates and date of photograph inscribed therein.
- Medical Certificate (as per DGCA standards)

After scrutiny of the documents and payment of fees, candidates will be issued "Letter of formal admission" and they should report to the A M / Chief Flight Instructor, Sha-Shib Flying Academy at Guna for joining the program.

After the formal admission the complete particulars of the candidate will be sent to the concerned police authority for verification of character and antecedents.

#### OVERSEAS STUDENTS

Overseas students may consult the Indian Embassy / Consulate in their respective countries to obtain a student VISA to study at Sha- Shib Flying Academy, Guna (M.P.). Security clearance from the DGCA is required for all foreign nationals to undergo flying training in India. SFA will process the necessary clearance on behalf of the student on receipt of application form and registration fees of US \$500 (non refundable).

The payment should be made in the form of Demand Draft / Bank transfer (in US Dollar) in favour of Sha-Shib Flying Academy, Guna (M.P.).

#### **GENERAL RULES AND REGULATIONS**

- Students should report to the classes regularly and in full uniform.
- Smoking and consumption of drugs/alcohol is strictly prohibited.
- The Academy maintains strict discipline. Students violating discipline are liable for severe penalty including expulsion.
- Students are required to fill in a prescribed declaration form supported by a joint affidavit at the time of admission.
- **Ragging**: Ragging among Junior & Senior Students is strictly prohibited with in & out of the premises of the Sha-Shib Flying Academy. A cordial relationship among the student is desirable & any violation of the disciplinary rules may invite stern action from the authorities.
- Any student found responsible for any damage to any movable or immovable properties of the institution such as aircraft, building, furniture equipment etc. etc. will be punished severely and the cost of damages along with fine will be recovered from the student concerned.
- Students are strictly forbidden from organizing or attending any unauthorized meeting in the campus or collection of money for any purpose without the prior written permission of the competent authority.
- Student must conduct themselves at all times in a fitting manner to bring credit to themselves and to the academy.

- MODE OF PAYMENT: Tuition and other fees prescribed should be paid on or before the stipulated date as laid down in the guidelines. All fees should be made by DD. in favour of SFA and receipt to be obtained immediately.

- Educational Qualification 10+2 or its equivalent examinations passed with Physics and Mathematics from a recognized Board / University.
- Class I Medical.
- Written examinations passed in Air Regulations, Air Navigation, Aviation Meteorology, Technical General, Aircraft and Engine Specific.
- Flying experience of minimum 200 hours in the last five years preceding the date of application.
- Flying Training in accordance with syllabus prescribed by DGCA.
- Possession of current Flight Radio Telephony Operator's License (FRTOL).
- RTR(A) licence from telecom department, Ministry of Communication.
- Pass in Flying Skill Tests.

#### DGCA REQUIREMENTS PRIVATE PILOT LICENCE (PPL)

- 1. Educational Qualification Xth class passed.
- 2. Age 17 years.
- 3. Medical Std. Class II Medical Fitness.


#### **HOSTEL FACILITIES**

#### **HOSTEL/ACCOMMODATION ASSISTANCE**

SFA has tied up with a local Hostel facility at Guna. The self contained and modern rooms are available as single & double accommodation on nominal charges. Boarding and lodging in the hostel is mandatory for all students during training. Dining facility is also available for the students at the hostel.

#### **HOSTEL RULES**

- All the hostellites have to deposit Rs. 5000/- (Five Thousand only) as caution money which will be refunded at the time of the hostellite leaving the hostel after deducting the necessary recoveries, if any.
- One year hostel fee should be paid in advance for availing hostel facility.
- A hostelite will have to stay in the room allotted to him/her with two or more inmates.
- Inmates of each room are jointly held responsible for the furniture and other fittings etc., and any damage to the hostel property is recoverable from the caution money.
- Guests are strictly prohibited from entering the hostel premises without prior permission of the warden.
- Once a student has paid hostel and mess charges and has been allotted hostel accommodation, under no circumstances the money will be refunded.
- Students may be expelled from the hostel for violation of rules and also for misconduct such as theft, abnormal behaviour, use of drugs and alcohol, indiscipline, non payment of fees, etc. etc. A student expelled on disciplinary grounds shall forfeit his fees and deposits including caution money.
- The management reserves the right to reject an applicant's admission to the hostel. In matters of admission and discipline, the decision of the management shall be final and binding.
- Ragging is strictly prohibited, if found guilty on the charge of ragging the concerned student will be expelled from the SFA.






